General Association Representation

I write to confirm the terms of our firm's retention as counsel because my experience has shown that the attorney/client relationship works best when there is an early mutual understanding about matters such as the legal fees and payment terms. If no retainer has been requested, we will track our time and send a monthly bill for legal services. Should we then terminate the representation, any funds held in trust will be returned to you less any and all fees we have earned but not billed, as of the termination date.

We typically do not charge separate costs for paper copies, phone calls, mileage, or secretarial services. However, copies, phone calls, courier fees or other extraordinary document-related fees greater than \$10.00 may be charged to you at face value. You are responsible for payment of all reasonable expenses we incur in the course of this representation. Advancements payable to others will be sent directly to you for payment or, if advanced by us, billed directly to you as part of our statement for legal services.

Our firm's policy is that statements for services and reimbursement for expenses and

disbursements advanced by us should be rendered on a monthly basis. Such statements are due and payable upon receipt, unless other arrangements have been made with us in advance. We reserve the option to terminate our representation if payment is not received within 30 days of the date of the statement.

If the foregoing terms of representation are acceptable to you, please sign this letter and return it to us at your earliest convenience.
